## ***How to enter***

1. If you or a family member has a challenge that requires a supportive competitive environment you are eligible to compete in Inclusive Skating events.  
More information is available in the [Classification](#) Handbook, (4<sup>th</sup> Edition).
2. Select the events that you are training for from [the Technical](#) Handbook (3<sup>rd</sup> Edition).  
All events are available at Glasgow 2019 this year, except for speed.  
Your coach will help you decide what events are right for you.
3. Undertake a relevant and supervised training program for your event.  
Your coach must be insured, safeguarding checked, trained in first aid and have the necessary skill and knowledge to coach you. We welcome contact from all coaches and can provide additional training and support to your coaches and those who care for you.
4. The Final Announcement will be issued in Autumn 2018.  
This will provide information on the online entry form and registration system.  
Fill out the online entry form, pay fee and submit entry form.  
The Final Closing Date is 1<sup>st</sup> February 2019.

£50 per skater for Compulsory Elements and Free Skating events for Singles  
£50 per Pair for Compulsory Elements and Free Skating events for Pair Skating  
£30 for Compulsory Figures competition and Workshop  
£20 Additional Compulsory Figure Workshop  
£30 Solo Pattern Dances  
£30 Couples Free Dance  
£30 for Solo Free Dance  
£30 for Synchro Group (2 to 4 skaters) to be paid once for team by named Team Leader  
£50 for Synchro Team (5 to 10 skaters) to be paid once for team by named Team Leader  
£70 for Synchro super teams (11 to 16 skaters) to be paid once for team by named Team Leader

The entry fee includes: competition entry, opening/closing/award ceremonies. Skaters must provide details of who their Chaperones, Coaches and Facilitators are for the purposes of accreditation. Chaperones, Coaches and Facilitators should register using the online Inclusive Skating system and are given free entry and accreditation to events where they have a skater participating. Workshop participants have free entry to the entire event.

Please note that the entry fees do not cover the full costs of the event and donations at the event and help with fundraising throughout the year are welcome.

Please note that the entire event is run by volunteers. Chaperones and carers are invited to assist with the smooth running of the event wherever possible.

We reserve the right to refuse entry to anyone whose forms and payments are not returned complete by the deadline.

Late entries may be considered at the discretion of the organisers.

The Organising Committee has limited classification places and will limit the entries accordingly. Entries will generally be accepted on a first come first served basis but the Organising Committee will also seek to ensure that as many countries as possible are represented and that skaters with all forms of impairment and ability are included.

Skaters that are on the current Inclusive Skating World Ranking lists have priority entry.

The Organising Committee has the discretion to accept or reject any entry without reason assigned.

## Venues

Main competitions and practices will be held at Braehead. Most of the competitions will be held at Curling Rink. If funds and the number of entries and ice availability permit it is possible that some of the events or activities will be held in the main Braehead arena. The arena is a standard international size ice rink. The harness event will take place at the Time Capsule, Coatbridge in advance of the main event at a date and time to be confirmed. The Time Capsule is located at 100 Buchanan St, Coatbridge ML5 1DL.

Braehead Curling Ice Rink has limited seating capacity with possible extra seating being brought in for the event.

The ice surface is a 7-lane standard curling rink. Approx. 110 x 150 feet.

The facility is heated and is fully covered.

Braehead Curling Rink is located within the Upper Mall of Intu Braehead Shopping Centre close to M8 and Glasgow Airport. The Curling rink is near the centre of the Upper Mall next to the Food court. The arena entrance is adjacent to the Food court on the Lower Mall.

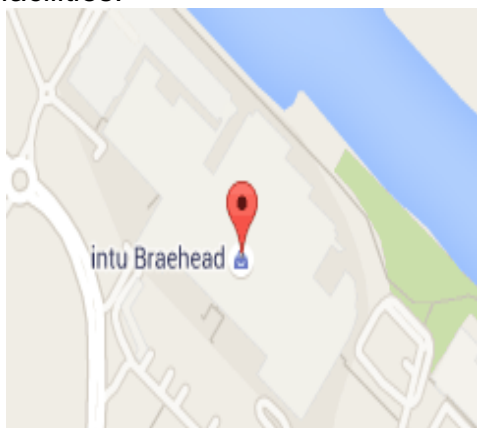
Braehead has ample free parking. There are disabled parking spaces and good wheelchair access throughout. The rink may be accessed from an entrance on the lower level adjacent to the car parks outside the Mall or from the Upper Mall of the Shopping Centre. Minibuses and coaches can drop off/pick up from several entrances.

Registration and the Competitors Information point will be located in the Seminar Room within the Curling Rink Café.

There are separate changing rooms and toilets for Ladies and Men, which are accessed through the curling rink. An additional changing area for skaters who use a wheelchair or who require gender neutral changing facilities will be located in a section of the café.

All competitions, awards and opening and closing ceremonies will take place on or at the Braehead curling ice rink. If there is any change of location or time this will be published at the main curling rink.

Braehead Shopping Centre in Scotland is a commercial development located at the former site of Braehead Power Station in Renfrew on the south bank of the River Clyde in Renfrewshire. It is particularly notable for its large shopping centre, arena and leisure facilities.

## **Accommodation**

Transport from hotel to the rink has to be arranged by the skater. The Organising Committee does not pay travel or lodging expenses for the skaters.

We understand that taxis who are willing to pick up from Braehead require a pre-arranged location so please take care to ensure that if you need a taxi for your return that you make specific arrangements with the taxi firm. Braehead is very large and there are several entrances so please ensure that you and the taxi are completely clear about which

entrance you are using especially for pick up. The Marks and Spencer's entrance is a popular location for pick up.

### **Medical Services**

Braehead has a system for medical emergency aid. There are emergency alert buttons located at rink side and there is direct access to the central control at Intu Braehead who have a system in place for alerting the emergency services and ensuring that the emergency services have speedy access to the rink. The nearest medical centre/hospital is the Queen Elizabeth University Hospital and Royal Hospital for Children 1345 Govan Rd, Govan, Glasgow G51 4TF. The Emergency phone number in the UK is 999.

As a matter of good practice all Inclusive Skating Coaches and Parent/ Guardians should also ensure that all individuals in their team or care complete a Health Information Form and retain a copy at all times during the competition.

Inclusive Skating has several trained Emergency First Aid Volunteers available throughout.

### **Insurance and Responsibility**

The event is covered by third party liability insurance through both Inclusive Skating and NISA. Inclusive Skating has its own insurance policy to cover the event. Inclusive Skating has also taken out the additional insurance available through NISA by virtue of being an Affiliated Association/Club of NISA.

All participants act on their own responsibility. Inclusive Skating and the Inclusive Skating Event Organising Committee accepts no liability or responsibility with respect to bodily or personal injury or for property loss or damage incurred by competitors, facilitators or officials or other participants in any capacity in connection with the Inclusive Skating Event Glasgow 2019 or any part of the event.

It is the sole obligation of each participant, to provide his or her own medical and accident insurance. Such insurance must assure full medical attendance and also the return of the ill or injured person to the home country by air transport or by other expeditious means.

It is a condition of the entry that all the participants (and their parents and/or guardians on their behalf) in the event hereby certify that they are physically fit to participate in the event and that they will not cause harm to others and that they have not been informed otherwise by a physician. It is the responsibility of the participant and their parents and/or guardians to notify the Organiser of any change in their health condition.

The participant and their parents and/or guardians acknowledge that they are aware of all the risks inherent in figure skating and agree on behalf of themselves and their family to assume those risks. As a condition of participation in the Inclusive Skating Event or any activities incident thereto, the participant and their parents and/or guardians waive any and all rights to claims for loss or damages caused by negligence, active or passive, of Inclusive Skating and the Inclusive Skating Event Organising Committee, and the entry of the skater shall only be accepted on the basis of this waiver.

## **Eligibility Information**

### **Inclusive Skating eligibility**

All skaters entering Inclusive Skating events must either:



1. Have an impairment as provided for in the IS Classification Handbook and provide the necessary supporting evidence. Further information on [classification](#) is available on the website.

Or,

Be a Unified Skater. Unified skaters have no impairment compensation added on to their skating score.

Some events operate on a unified basis, e.g. compulsory figures. Unified inclusion also applies to those who are members of a pair, dance or synchro group or team. Family members of Inclusive Skaters can compete as unified skaters. Unified inclusion will also apply if the skaters have a mental illness or other impairment not covered by Inclusive Skating impairment compensation classification or there are circumstances that are such that they require the supportive environment of the Inclusive Skating event.

2. Have followed a relevant and supervised training program,
3. Be technically capable of competing at the level of competition that they are entering,
4. Abide by all relevant Codes of Conduct at all times.

### **Inclusive Skating Classification**

Classification gives each skater an impairment compensation, depending on how their medical condition(s) affect the ability to learn, practice or participate in ice skating. Information on Classification is available on the [website](#). Skaters who wish further advice on classification please contact [margarita.msb@gmail.com](mailto:margarita.msb@gmail.com)

Classification also provides the organizers with information on the needs of the skater. Inclusive Skating will seek to ensure that the needs of the skater are met at all times. Inclusive Skating rules allow the organizers to make all reasonable adjustments necessary to ensure that the Inclusive Skater can take part safely and enjoyably. Video entry is permitted too. During classification facilitators can be approved to assist the skater on the ice where this is necessary.

Classifiers will be present at the event for the purpose of classification. Skaters who have not yet been classified should provide the necessary supporting evidence as arranged.

Medical Information should only be communicated directly to the medical classifiers at Classification. Please do not send any information.

Skaters who have already been classified do not require to be reclassified unless there is a material change in their functioning for ice skating. Records of the Whole person impairment compensation (WPI) from previous classifications are kept and are now available on the [Inclusive Skating World Ranking](#) lists for your information.

Classification of skaters will follow the **Inclusive Skating [Code](#) of Classification and Inclusive Skating [Classification](#) Handbook**. The Code and Handbook rules are drafted

in accordance with the IPC Generic Code on Classification as well as pertinent IPC Rules and Regulations.

Where skaters are fully classified an impairment compensation will be added to their skating score that reflects the specific impairments of the skater.

If skaters meet the minimal criteria for impairment but do not wish or are not able to provide sufficient medical evidence of their impairment the skater will be given a 5% whole person impairment compensation and an impairment result will be calculated accordingly. Such skaters will be given a Review classification status and this will remain in place until the necessary medical evidence is provided to establish a full classification.

### **Inclusive Skating British Championship eligibility**

Inclusive Skaters will be entered in the British Champions where they are

- a British Citizen or Resident in UK continuously for a minimum of 1 year prior to the closing date.
- Meet any age requirements
- Have obtained a classification assessed under the procedures in the Inclusive Skating Classification Handbook as having an impairment according to the Rondinelli Scale (Guides to the Evaluation of permanent impairment. 6th Edition Ed. Robert D. Rondinelli.

### **Volunteer (Coach/Escort) eligibility**

All volunteers, coaches, chaperones and facilitators should comply with the Inclusive Skating Code of Conduct for Officials.

Volunteers should meet the minimum age requirement of 16 on the date of the Opening Ceremony. Volunteers who are 16 & 17, years of age or younger if they are flower girls or boys or runners should only be assigned to fulfill supervised roles.

### **Athlete to Volunteer (Coach/Escort) ratio**

All skaters must have at least one person to act as a chaperone during the event. The maximum ratio of Athletes to Volunteers (coach/escorts) for this event is 4:1.

Each skater may have accreditation for one coach, one choreographer, all necessary facilitators and 2 parents and or guardians. Please supply names for the purposes of accreditation during the event. Additional accreditation to family members may be issued at the discretion of the organisers.

### **Inclusive Skating Coaches and/or Facilitators**

Coaches and/ or Facilitators are responsible for managing the skater for competition purposes. Coaches and/ or facilitators are also responsible for submitting the planned program content sheet relating to the competition and checking that all individuals are entered in to the correct events and should keep a photocopy of every form that is submitted. Meetings for all coaches and/ or facilitators will be held at Braehead. A notice board adjacent to the rink and the registration desk will be used to advise on competition information and dates and times of any meetings.

## **Skating and Technical Rules**

### **Events**

All participants can enter a maximum of one event in each section. In other words, one compulsory elements, one compulsory figures, one free skating, one solo pattern dance, one free dance, and one pair skating event (compulsory elements and free).

Skaters may enter several synchro group and team events. Skaters must consider the recovery and changing time required and only enter additional events if they have sufficient time. The organisers will not delay the event to provide changing time.

### **Competition Format**

Each skater performs once in each event at the specified level. Additional results are generated by applying the different classifications, age and membership criteria. Inclusive Skating competitions and Championships will be split according to Pre-Novice, Novice, Advanced Novice, Junior, Senior and Master.

Adult skaters can choose to enter Senior with no age-related compensation or Master with an additional age-related compensation.

The Masters age related compensation Score is calculated from the minimum hypothetical score obtained at the level of participation for that impairment.

The age-related compensation is 1% of the average hypothetical score for each year that the skater's age is 30 or more on 1 January 2019.

The age-related compensation score shall be added to any impairment compensation as a percentage of the remainder to determine the total compensation. The impairment compensation with the age-related impairment compensation is added to the skating score achieved as a result of the performance to determine the final result. If an age-related impairment compensation is added then no impairment compensation is awarded for degenerative, wear and tear and age-related conditions. Pre-existing conditions that are not age related can receive impairment compensation and be added to the age-related impairment compensation.

### **Sports Rules**

The competition will run in accordance with the Technical Handbook 3rd Edition, the Announcement of the event and Inclusive Skating Rules. The Inclusive Skating scoring system will operate with the addition of impairment compensation and the Inclusive Skating consensus judging will be used.

### **Planned Programme Content Sheets**

A planned program content sheet should be filled in through the online system and/or returned before the event. The Inclusive Skating planned program content sheet will be used as the marking sheet for the event. Only one form is required for each free dance pair or synchro group or team.

The Technical Panel will call the element as permitted under the rules for that level and this may be different from the element identified in the programme content sheet provided by the skater.

### **Assistance, Facilitators, Frames and Harness**

Please provide the organizers with information of the current and up to date needs of the skater. This applies even if you have already been classified and do not need to be reclassified. There is space for this in the entry form.

Competitors who wish to use a facilitator should identify the name and purpose of the facilitator in the Entry Form. If the facilitator needs to go on the ice (e.g. for the visually impaired skaters) then this should be specified. The facilitator's name must be stated in the competitor's entry form.

The facilitator must keep assistance to the minimum necessary.

There may be more than one facilitator if needed.

Facilitators are only allowed on the ice during competition if approved in advance or at classification.

The facilitator may be provided with a microphone to communicate with the referee during the event where necessary. For further details please refer to the [IS Rules](#) on the responsibilities of Officials.

Skaters may also use a support frame to facilitate their performance if authorised by the classification process. Any support frame must be provided by the skater and is used at the skater's own risk. Classification will only authorise the skater's need for a frame and will not consider or approve the design of the frame itself.

Skaters may also use the harness to take part in the BHF competition at the Time Capsule Leisure Centre, Coatbridge. Skaters wishing to use this facility should specify this in their Entry Form.

### **Music**

Normal speed CD and no rewritable CD.

CD (Compact Discs) format must be handed in at the time of Registration.

Each CD must be properly inserted into a case or CD envelope and clearly show the name of the Skater and Level. Skaters must provide a back-up copy of the music in CD.

An additional electronic version for each programme is also permitted as a back-up.

The disc should also show the running time of the music (not the skating time),

The titles, composers and orchestras of the music to be used for the individual programmes, must be listed for each competitor and attached to the official Entry Form for Competitors, or turned in to the Organising Committee at the time of registration.

### **Maximum Effort Rule**

Coaches must ensure that competitors participate honestly and with maximum effort in all competitions. Individuals who are identified as not participating to their full potential with the intent of an increased impairment compensation will be disqualified from the competition.

### **Uniform, clothing and equipment**

Attire must be suitable for athletic performance. Skaters are advised that the use of props is not permitted.

It will be mandatory for skaters to wear their skating competition attire and skates during the Award ceremony, Opening and Closing Ceremony for the purposes of group photographs.

**NO TRACK SUITS, SWEATSHIRTS, TEESHIRTS, HATS, CAPS OR ANY OTHER CASUAL ATTIRE WILL BE ALLOWED ON THE ROSTRUM.**

### **Officials decisions**

At all times, the Officials decision are final and all individuals must respect all Officials as well as opponents in an appropriate manner.

### **Classification Protests**

Protests will only be accepted from the named coach, regional Head Coach or Head of Delegation, and must be put in writing and submitted **within 30 minutes** of the conclusion of the event in question but before any awards presentations. All protests must be accompanied by a **£20** deposit (which will be refunded if the protest is upheld). Video recordings will not be acceptable as evidence to support a protest and protests relating to an Officials decision will not be accepted. A review process following the Inclusive Skating Code of Classification will apply and the decision shall be final.

### **Results**

Results will be posted on the Inclusive Skating website and on a bulletin board at the rink. Results will not normally be announced immediately following each competitive performance.

Skaters skate once in each event and are included in the Inclusive skating results for that level and awarded medals accordingly. Additional results may be generated according to specific disability classification and Nationality.

The first three placed skaters in each inclusive skating event will be awarded medals.

Separate medals/ cups will also be awarded for Inclusive Skating British Championships.

### **Awards**

Awards will be given out in accordance with the Announcement.

Please ensure that all persons wishing to take photographs during the awards ceremony have their accreditation badges permitting the taking of photographs on them at all times. An official photographer may also be available.

### **Other Information**

#### **Registration**

Registration will take place at the registration desk where skaters, coaches, facilitators and parents and carers will receive their accreditation for the event. Skaters must leave their music at the registration desk and the coach should hold a spare copy of the music at all times.

Registration will be available throughout the event. Please give volunteers time to set up.

#### **Competition Readiness**

Competitors must arrive at the ice entry area at least 15 minutes prior to the start of their event and should accommodate any changes in timetable. Coaches will not be able to

gain access to the ice once the competitor is taking part in the warm up and competition. Only facilitators approved during classification are permitted on the ice during competition, A coach can be a facilitator.

### **Photos/Videos**

If individuals wish to take any photos/videos during the competition, they will need to register their camera first at the registration desk. Otherwise, the taking of video and photography within the arena is prohibited. An official photographer may be present at the event. In any event, if parents or guardians wish to video or photograph skaters who are not their own children then they may obtain a video/ photography permit, which will allow them to video/ photograph a named individual(s) from a designated area in the arena. Permission for this may be granted in advance of the event or at the Registration desk during the event. Parents and guardians who are named in the entry form are given permission to take photos/ videos in advance by virtue of the acceptance of the entry of their skater.

By entering the event permission is given to Inclusive Skating to use an athlete/unified partners' name and any photos or videos taken of them in the press or for publicity to promote Inclusive Skating. If this permission has not been given for an athlete, it is the responsibility of the Head Coach to notify the Event Manager in advance so that appropriate action can be taken. As all skaters are videoed during the event those who do not consent will not be permitted to skate in the event.

All videos and photos will be available to download from the Inclusive Skating YouTube channel and the event may also be livestreamed. Details of video and photo distribution will be distributed upon request during and after the event.

### **Publicity Waiver**

(Confidential medical information will not be disclosed.) Skaters their parents/guardians and coaches hereby certify and warrant that the music and choreography presented and used by the Competitors have been fully cleared and authorised for public use and consent to use of his or her name, biography and likeness on or in connection with any television or radio programme broadcast and re-broadcast throughout the world, motion picture, print media or the advertising and publicising of such programme, without further clearance or payments of any kind on the side of the Organising Committee, Inclusive Skating, and the relevant television network or broadcasters being required. At the time of registration at the event the skater and all Team Leaders, or other representatives of the skater, club or ISU Member entering, should present a signed compliance. If this is not forthcoming consent will be presumed by virtue of entering the competition. This is a public event.

### **Media Accreditation**

Media accreditation may be applied for. Applicants will be asked to produce a DBS or in Scotland a PVG certificate and/or Press Credentials. Media Accreditation will allow photography but only from a designated area in the arena.

Local and national television and press will be invited.

### **Entertainment**

Braehead is adjacent to the Xscape leisure complex and has a wide range of activities available.

### **Family Members/Supporters**

We welcome all family members/supporters to attend the event and will be providing a specific area for them to view the competition from. The seating area in the café has been improved and additional seats are now available. This area is heated and may be particularly suitable for spectators who need to be seated in a warm environment. Spectators standing in the area in front of the café are requested to avoid blocking the view of spectators who are seated in the café spectator area. ### **Anti-Doping**

An anti-doping control will not necessarily be carried out during the competition. However, Competitors are advised that they should always act in accordance with the WADA Anti-Doping Code and the regulations of all relevant governing bodies. For all skaters over 18 years of age, it is a condition of entry to all events and competitions, that they are willing to participate in anti-doping at that event. Parents / Guardians of skaters under 18 are required to sign the Parental Consent Form.

### **Organisation**

The organisation of the competition is the responsibility of Inclusive Skating, and it reserves the right to take any measures, as to the running of the event necessary to ensure that the competitions run smoothly.

### **Coaching and Instruction**

Practice Ice will be available and all coaches and Facilitators are welcome to coach and assist their skaters. Please provide names for the purposes of accreditation.

### **International Competition Qualification**

This event will be an event through which athletes can qualify to be considered for selection to represent Inclusive Skating for future skating events.
