- 4.9 facilitate the development and operation of globally recognised competitions in skating for skaters with an impairment at national and international level
- 4.10 liaise and co-operate with governing bodies of sport in the UK and across the world to facilitate the organisation's purposes
- 4.11 liaise and co-operate with disability specific groups and other organisations to facilitate the organisation's purposes
- 4.12 facilitate the development of a coaching programme for coaches of impaired skaters and to liaise and co-operate with all relevant coaching organisations for this purposes

APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

The eleventh year of Inclusive Skating has been of green shoots of recovery. Virtual activities have continued to prevail, and skaters are returning to activities within their training environments. Volunteers are engaging in training in greater numbers and the Register of Safety Advisors has now been joined by a Register of Leaders.

The virtual rules and new free element and off ice events developed for lockdown have proved popular and have been incorporated into the updated Technical Handbook 2022 and the Classification Handbook 2021. So, the lessons learned and experiences from lockdown are proving valuable. The Virtual World championships 2021 were especially popular with continued global participation.

The various activities, provided as a result of the funding and community support, have an overwhelming thumbs up from the community! Importantly, the zoom sessions are becoming more important for skill development for the Coaching and Duke of Edinburgh Award Programme.

Significant achievements for the charity behind the scenes are:

- Provision of off ice activities and continuing with coaching courses
- Participation in Evaluation Support Scotland training funded by the National Lottery.
- Recognition as an Approved Activity partner with the duke of Edinburgh Scheme and relationship with DofE Direct.
- Inclusive Skating Coaches seminar online
- Virtual World Championships 2021 held successfully in 11th and 12th December 2021
- CIMSPA recognition as a CIMSPA Employer and Training Partner and successful QAA review
- Adjustment of Technical Handbook to virtual environment and New Events
- Adjustment of Classification Handbook to virtual environment and New Events
- Recognition and continued membership of the Sport and Recreation Alliance, Welsh Sports Association, Northern Ireland Sports Forum and the Scottish Sports Association
- Active participation in many government working groups and home nation sporting associations including the All-party group on Sport and Physical Recreation
- Parasport Come and Try
- Visual Impairment Seminar at Uttoxeter Ice Rink
- Learn to skate at Parkhill School for additional support needs, 2 visits to Parkhill School and 2 sessions at the rink.
